SECRETARY-GENERAL'S REPORT 1981-83

Administration

The Association's secretariat continues to be situated at the International Seismological Centre, Newbury, England.

Financial

Accounts for the period 1979-82 and a budget for 1983-86 are appended, with explanatory notes. The Association's reserves remain at about \$20,000.

Bureau

The Bureau met in Newbury in March 1982, with the main item of agenda being the programme and other arrangements for the 22nd General Assembly at Hamburg in 1983.

Meetings

Proceedings of the 21st General Assembly, held in Canada in July 1981, have been published in the Newsletter. A list of meetings sponsored by IASPEI and its Commissions from 1981-83 is attached.

Commission Activities

The European Seismological Commission, the International Heat Flow Commission and the Commission on Controlled Source Seismology have held independent meetings, and the Commission on Practice has met at the ESC meeting at Leeds in 1982. The Commission on Physical Properties of Material in the Earth's Interior also co-sponsored a symposium at this meeting.

Newsletter

The IASPEI Newsletter continues to be issued at about six-monthly intervals.

Links with UN Agencies

Following the pattern established at the 21st General Assembly in Canada, contracts have been carried out for Unesco to hold specific meetings, and to convene joint Working Groups in areas of interest to both organizations. In particular, support was given in 1982, for meetings on Anisotropy (USSR) and on Lateral Heterogeneity in the Mantle (UK) and for a Workshop on Historical Seismograms (Japan).

The Secretary-General has represented the Association at meetings of the Unesco/UNDRO Advisory Committee on Earthquake Risk in 1982 and 1983, and has been closely involved with Unesco in a Programme for Assessment and Mitigation of Earthquake Risk in the Arab Region.

Working Group on International Experimental Sites for Earthquake Prediction Research
This group will meet again during the 1983 General Assembly to consider reports
on Unesco-sponsored visits to possible sites in Greece, Turkey and Australia.

Working Group on Historical Seismograms

This group held a Regional Workshop for the Asian and Pacific area in Tokyo in December 1982, with financial support from Unesco and NOAA. A further meeting is being held during the Hamburg General Assembly to consider the Latin American and European areas.

Working Group on Code of Practice for Earthquake Prediction

A new joint IASPEI/Unesco Working Group is being convened immediately before the Hamburg Assembly to consider this topic.

Strong Motion Recording

A grant has been received from ICSU to prepare during the Hamburg Assembly a report on Enhancement of Earthquake Strong Motion Recording at World-Wide Observatories. This is being undertaken by the Commission on Strong Motion Seismology.

Future Meetings

A Regional Assembly of IASPEI will be held at Hyderabad, India, 31 Oct - 7 Nov 1984. This will be the Association's first meeting in Asia. The first circular is now available.

The 23rd General Assembly of IASPET will be held at Tokyo, Japan, in August 1985.

I thank the Officers of the Association for their help during this period, and also the Director and Staff of the International Seismological Centre for their support in the running of IASPEI affairs.

EXCHANGE ADJUSTMENTS

Much of the Association's administrative expenditure is in pounds sterling. Each year the accounts are balanced in US dollars, using the exchange rate in force at the end of that year. In the first years of the period the falling dollar resulted in an accounting gain, while in recent years the strengthening dollar resulted in an accounting loss. A strengthening dollar is to the Association's advantage, and the resulting accounting loss merely reflects how much better off we would have been if the final exchange rate had been in force throughout the entire year.

GENERAL

Two pleasing points to note are the receipt of \$6,276 in interest, and the fact that more than \$120,000 or \$0% of the Association's total expenditure has been devoted to Assemblies, Symposia and Meetings.

The sum of \$5,359.87 shown as transferred from the IUGG Account to the Grants Account, represents money paid from general Association funds to be reclaimed from contract-giving agencies. This sum was received early in 1983. The Association finished the period with a cash balance of US \$20,102.88.
